The Consignee agrees to leave merchandise with the seller for a minimum of 90 days and no longer than 365 days.

The Consignee must advise the Seller of any flaws or imperfections in/on the item(s) known at drop off

After 365 days, the Consignee should contact the Seller. Both the Seller and the Consignee will evaluate all merchandise that is not sold at the end of the agreed upon timeframe and decide to either continue or terminate the contract. If continued, the price may be dropped at the Seller's discretion. If the Consignee does not pick up the item(s) within 60 days of the end of the agreed upon term the Seller will then retain and own all rights to the above-mentioned item(s).

The Consignee agrees that they are leaving their item(s) at their own risk. The Seller will not be responsible for fire, water damage, earthquake, or any other uncontrollable events.
